SA TileGuard HT is ideal for adhesive bonding of cement and clay tiles as well as high temperature underlayment protection under metal roofing products. GAP WaterGuard Self-adhered TileGuard HT underlayment serves a dual role as a flashing membrane, helping protect areas susceptible to leaks such as valleys, roof to wall transitions, and around vents and skylights. Ideal tile underlayment in steep slope applications 2:12 and above.

**Product Specifications:** GAP WaterGuard Self-Adhering Metal and Tile Underlayment is manufactured on a non-woven fiberglass mat with a dual SBS polymer formulation and a non-woven high temp polyester top surface that is UV stabilized and an excellent skid resistant material. The bottom coat is an aggressive asphalt-based adhesive, protected with a factory applied, split-release film that is removed prior to installation. The specialized 3" adhesive selvedge edge improves overlap bonding.
